<u>ORDER</u>

- 1. As per the G.O. read as $1^{\rm st}$ paper above, Administrative Sanction had been issued for incurring an expenditure to the tune of Rs.50,00,000/-(Rupees Fifty Lakh only) for implementing the Project Zero Landless (Citizen) Kerala 2015 from the Head of Account "2029-00-800-76 Zero Landless Kerala".
- 2. An amount of Rs. 7,00,00,000/- (Rupees Seven Crores only) has been authorised in the final batch of Supplementary Demands for Grants for 2012-13 under the Head of Account "2029-00-800-76 Zero Landless Kerala" in order to regularise Rs.50 Lakhs addtionally authorised vide G.O. Read as 2^{nd} paper above as sanctioned, in the G.O read as 1^{st} paper above, and to provide additional fund of Rs. 6.50 Crore for issuing One Lakh pattayams to the landless people under this Scheme.
- 3. Now, the Joint Commissioner, Land Revenue & Special Officer, Zero Landless (Citizen) Kerala 2015 Project has submitted a detailed Project Report for incurring expenditure to the tune of Rs.6,50,00,000/- (Rupees Six crores fifty lakhs only) in view of the decision of Government to issue Pattayam for One lakh landless families by 15th of August 2013.
- 4. Government have examined the matter in detail and are pleased to accord Administrative Sanction for incurring an expenditure to the tune of Rs.6,50,00,000/- (Rupees Six crores fifty lakhs only) for implementing the project, Zero landless (Citizen) Kerala, 2015, from the funds moved by way of Supplementary Demands for Grants (final batch) for 2012-13 by debiting to the Head of Account 2029-00-800-76 Zero Landless Kerala.

5. The Commissioner of Land Revenue will ensure proper utilisation of the funds and furnish Utilisation Certificate in due course.
